Consequent upon the selection of Assistant compilers in the Finance Department, (Divisional Cadre, Jammu/Kashmir) vide above referred recommendations from J&K Service Selection Board and subsequent to Finance Department's communication numbers:- **FD-FO/31/2022-03 dated:-08.09.2022** and **FD-FO/31/2022-03 dated:-21.09.2022** and further on the basis of Final verification of character and antecedents of the selected candidate conveyed by the CID JK, sanction is hereby accorded to the temporary appointment of **Talib Hussain S/o Sh. Mubarak Ali Sheikh, R/o Bhagwah District Doda, under EWS category, as Assistant Compiler in Pay level 4 (25500-81100) Divisional cadre Kashmir.**

The appointee shall report physically in the office of Joint Director, J&K Funds Organization, Kashmir within a period of **21 days from the issuance of this order** and in case the appointee fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice as per the circular No. 08-JK(GAD) of 2019 dated 04.12.2019.

The appointment shall be subject to the following conditions:-

A. The appointees shall be allowed to join only on production, checking and Verification of the following certificates in original:-

1. Academic Qualification Certificate.
2. Matriculation/ Date of Birth Certificate.
3. Health Certificate issued by Chief Medical Officer concerned.
4. Domicile Certificate issued by the Competent Authority.
5. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned

- appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
6. Category certificate wherever applicable.
 7. Any other relevant certificates as required under rules.

B. The appointment of the candidate shall further be subject to the following conditions to be fulfilled by the Head of Office alongwith ascertaining genuineness of the certificates and recognition status of the institutions:-

1. The candidate shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her **academic/ technical/ category certificate**, is received, from concerned authority, he shall have no right to claim his appointment as Assistant Compiler and the same shall be deemed to have been cancelled ab-initio .
 2. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio and this office be kept posted so that appropriate criminal proceedings against such candidates is initiated.
 3. The salary of the appointee shall not be drawn and disbursed to him unless and until satisfactory report about genuineness of his certificate(s) is received from the concerned quarters.
 4. The appointee shall be on probation for a period of 02 years.
 5. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
 6. The inter-se-seniority of the appointee shall be in the order of merit list issued vide No: **-SSB/Secy/Sel/J/K/div/2022/5889-94 dated:- 02.09.2022** by the J&K Service Selection Board.
 7. The appointment shall be subject to outcome of writ petition(s) if any pending disposal before any competent court of Jurisdiction related to the selection list.
- Formal order for the posting of the appointee shall be issued by Joint Director, J&K Funds Organization, Kashmir.


