In terms of the Jammu and Kashmir Civil Services (Higher Standard Pay Scale Scheme) Rules, introduced vide SRO-14 dated 15.01.1996 read with SRO-225 dated 04.07.1997 and amendments and clarifications thereto issued by the Finance Department from time to time and as recommended by the in House Departmental Promotion committee members in its meeting held on 13<sup>th</sup> of March, 2023, sanction is hereby accorded to the grant of Higher Standard Pay Scale(HSPS) in favour of **03** Members of the J&K Subordinate Accounts (Unfunded Debt ) Service, listed in **Annexure "A"** to this Order, w.e.f. from the date(s) and condition(s), if any, indicated against each.

The concern DDO's may ensure further:-

**01. That the employee availing the benefit of in-situ promotion shall furnish the form of option and undertaking to the effect that as and when he/she becomes due for functional promotion, he/she will not refuse and shall forfeit this benefit and shall be reverted back to original lower grade.**

**02. That the Higher Standard Pay Scale granted to the official is/was not under suspension or charge sheeted under the provision of J&K classification control and appeal rules, on the date of eligibility.**

**03. That the period of leave without allowances, if any not been approved by the competent authority to be counted for the purpose of annual increment shall not be taken into account for reckoning of period of 9 years qualifying service for HSPS.**


